"[8] There are four dominant and major role players - competing against each other - within the waste management industry in South Africa and various other different and smaller competitors. The four major largest role players within the waste management industry are able to deliver a complete and holistic service over the spectrum of waste management, namely, industrial waste management; commercial waste management; medical waste management; domestic waste management; mining waste management; municipal waste management and landfill management. There is a further sub-category of hazardous waste management created within any of the aforementioned categories. Governance: Umgeni Water board to go amid forensic probe

"Water and Sanitation Minister Nomvula Mokonyane would not renew the term of the current board of Umgeni Water when it expired this month, the parastatal announced yesterday (Wednesday), according to a report in The Mercury. The term of the 10-member board ends on 1 July. The report notes an anonymous whistle-blower recently made damning allegations of corruption and wrongdoing against senior officials of the state-owned water company. The allegations led to chief executive Cyril Gamede being placed on precautionary suspension. A forensic investigation is expected to start next week. Umgeni Water spokesperson Shami Harichunder said the Minister would soon begin the process of replacing the board."

Legislation: Protected Disclosures Bill on way to President

"The Protected Disclosures Amendment Bill is finally on its way to President Jacob Zuma for signature. Reflecting NCOP recommendations for a strengthened definition of the term 'occupational detriment', a 'D' version of the Bill not yet publicly available was passed yesterday by the National Assembly – paving the way for the introduction of measures aimed at facilitating the disclosure of unlawful or irregular conduct on the part of both public and private sector employers. Opposed by the DA and ACDP, the Bill has been criticised by some public interest organisations for its perceived potential to deter whistle-blowing (GroundUp)."
